WESTERN JOSHUA TREE REGULATIONS

As part of the candidacy process, three interim regulations under Section 2084 of the Fish and Game Code were adopted allowing for permits to be issued by the California Department of Fish and Wildlife for incidental take (removal) of western Joshua trees during its year-long candidacy period for listing under CESA. The three regulations, known as orders, are as follows:

Special Order 749.11 allows for the issuance of a permit for the removal of a dead western Joshua tree or the trimming of a live western Joshua tree. Permits for these activities may be issued without payment of fees if they meet certain conditions as described in the order. The text of the regulation can be found here.

Special Order 749.12 permit confers to the City of Palmdale, Town of Yucca Valley, and San Bernardino County (for activities in unincorporated areas) authorization to issue incidental take permits for impacts to western Joshua trees resulting from certain actions including the construction of a single-family residence, accessory structure, or public works project. The third Special Order 749.10 applies to take of western Joshua trees incidental to the development of planned solar energy projects in Kern and San Bernardino Counties. The text of the regulation can be found here.

Ordinances

The City of Palmdale and the Town of Yucca Valley have adopted ordinances for the purpose of implementing Special order 749.12. The ordinances can be found here:

- Yucca Valley (2084 permit expired in May 2022)

San Bernardino County did not adopt an ordinance under section 2084 for incidental take permits.

Applying for a Permit

Residents of the Town of Yucca Valley and the City of Palmdale may apply directly to their city of jurisdiction to obtain a permit for the removal of dead or hazard trees or for impacts to the western Joshua tree from the planned construction of a single-family home, accessory structure or small infrastructure project.

Residents in unincorporated areas of San Bernardino County who wish to remove a dead or hazard tree must apply directly to the California Department of Fish and Wildlife. For planned single-family home, accessory structure or small infrastructure projects in unincorporated San Bernardino County that are built in the vicinity of western Joshua trees but will not result in their removal, persons must adhere to this technical guidance document.

San Bernardino County currently does not have a permit program in place for the planned removal of western Joshua trees associated with the construction of single-family homes, accessory buildings or small infrastructure projects. Permits for these types of projects will need to be obtained through the California Department of Fish and Wildlife.

Note: There is no fee for permits to remove dead and hazardous trees.

To apply to the California Department of Fish and Wildlife:

Permit request must be either emailed to the Department at WJT@wildlife.ca.gov or mailed to the Department at California Department of Fish and Wildlife, Habitat Conservation Planning Branch, Attention: Western Joshua Tree Permitting, P.O. Box 944209, Sacramento, CA 94244-2090. You must include the street address of the property on which the western Joshua tree is to be trimmed or removed. The request must also include photographs that demonstrate that the dead tree or limb(s) to be trimmed meet at least one of the requirements in subsection (b). Subsection 749.11(b) describes the conditions under which the Department may issue a permit to authorize either the removal of a dead western Joshua tree or the trimming of a western Joshua tree, without payment of mitigation or other fees or mitigation.

To apply with Yucca Valley

Approval for a 2084 permit takes place with the Town of Yucca Valley Planning Commission.

Reporting Violations

The three interim regulations passed governing take of Joshua trees are California state law. Violators of the regulations can be fined or be subject to prosecution. The California Department of Fish and Wildlife is the main enforcement entity. Enforcement for applicable violations within their jurisdiction has also been delegated to the Town of Yucca Valley and the City of Palmdale.

To report a possible violation, the process is as follows:

California Department of Fish and Wildlife

The first point of contact for reporting is California Fish and Wildlife's CalTIP service.

If the violation takes place where there is an ordinance in place, also report the violation to code enforcement.

<u>Documentation of violations is helpful to law enforcement</u>. Some details that could be helpful include:

- The date and time of the violation
- Vehicle descriptions and/or license plates
- Details of the violation the size of the area and number of trees, is it ongoing or after the fact
- Photographic or video documentation

We want to emphasize that your safety is paramount and that you should not put yourself in danger. If there is any potential for confrontation, we recommend you do not gather information/evidence, but instead, that you call law enforcement from a safe location and that you give them the location and a description of what you saw. If you can wait, meet them when they arrive, answer any further questions they have, and give them directions to the location of the violation.

<u>Timely reporting of violations is important</u>. If a wildlife or code enforcement office can reach the scene while the violation is taking place, it makes it much easier to prove and support.
